#### INTERIM SUPERINTENDENT'S REPORT

Dr. Alvarez reported that it has been a busy summer, particularly the last two weeks of school. He noted the New Staff Orientation on-boarded 8 new employees last week, while new student orientation at all schools will occur this week. Additionally, Stronge evaluation re-certification and LinkIt training for all school administrators have occurred.

He mentioned an Administrative Team Meeting and a Principals Meeting are scheduled for later this week to address District goals and priorities as we move into the new school year.

He noted curriculum approvals on the Board Agenda with particular attention to the inclusion, in the ELA curriculum, of *Phonics First* for grades K-2--a nationally accredited and multisensory approach to reading, which infuses Orton Gillingham's 7 principles of instruction. All K-2 teachers and interventionists attended extensive training sessions during the last week in June in

preparation for implementation this September. Also, Holdrum will be implementing two new 8<sup>th</sup> grade electives: (1) *Innovation through Aviation* focusing on the history of flight, while infusing interdisciplinary connections; and (2) *A Revolution of Personal Liberty: Your Rights as a US Citizen* focusing on the structure of the US Constitution and basic rights granted to US citizens through the Bill of Rights.
